INTRODUCTION

On June 11, 1996, Callaway Golf Company, a California corporation (the "Company"), filed its Registration Statement on Form S-8 (File No. 333-5719) relating to 2,000,000 shares of the Company's common stock, \$.01 par value (the "Common Stock") issuable pursuant to options to be granted under the Company's 1996 Stock Option Plan (the "Plan"). On February 14, 1997, the Board of Directors of the Company approved and adopted, subject to shareholder approval, the First Amendment to the Plan, which increased the maximum number of shares of the Company's Common Stock issuable upon the exercise of options granted or to be granted under the Plan from 2,000,000 to 3,000,000. On April 17, 1997, the Company's shareholders approved the First Amendment to the Plan at the Company's 1997 Annual Meeting of Shareholders. This Registration Statement on Form S-8 is filed by the Company relating to the 1,000,000 additional shares of the Company's Common Stock which are issuable upon the exercise of options to be granted pursuant to the First Amendment to the Plan and consists of only those items required by General Instruction E to Form S-8.
